**Call to Order:** Chris McCandless called the meeting to order at 9:11 am.

### Pledge of Allegiance

#### 1. Approval of the Teachers' LEA Specific Licenses (Action Item)

Mr. Oguz proposes that an LEA specific License be approved for a newly hired teacher so that she can teach these courses while working toward obtaining her state license.

An LEA specific License would allow for this teacher to teach these subjects for three years and only in our LEA. Three years should be a sufficient amount of time for her to earn her state license in these subjects.
